Repeated landings and take offs in areas that may be inundated in shallow saline, fresh water or diluted sewage effluent with varying soil and topographic conditions.
- Surveying over land and water (up to 10km offshore) across many sites in the Northern Territory. The nature of the work is low level flying; includes surveys for dugong, leatherback turtles, dolphins, magpie geese, ghost nets and weeds of national significance.
- Weed management including survey, inspection, research and aerial application of pesticide/ herbicide. This requires both transportation and application of chemicals.
- Feral animal management, including reconnaissance, spotting, dropping of baits and aerial culling of feral animals such as camels, buffalo, donkeys, horses and pigs. The nature of the work is similar to mustering and low level flying.
- Water sample transportation from remote communities.
- Services associated with food and fodder relief.
- Emergency services to assist NT Police, such as to attend an accident or search for a missing person.

The contract is for an initial period of 48 months.
